## Tack Equipment Coverage

Great American offers the ability to insure tack equipment in your care, custody or control that is owned by you and belonging to others. This is an optional coverage offering that can be added to your Mortality Policy for a small additional premium.

Tack equipment includes any equipment used to ride or control a horse, including but not limited to saddles, girths, stirrups, cinches, bridles, bits, martingales, halters, fly masks, lead ropes, whips, reins, wraps, or sports boots.

The following two options are available to cover tack equipment:

**Unscheduled Tack Equipment:** Unscheduled Tack Equipment coverage provides protection for tack without the hassle of providing a listing of equipment to be covered. The following limits of insurance are available:

Limit on any one item	Maximum on any one loss	Deductible
\$500	\$2,500	\$500
\$1,000	\$5,000	\$500
\$2,500	\$10,000	\$500

**Scheduled Tack Equipment:** For your more expensive tack equipment, you also have the option to list each tack item with a specified limit of insurance. Deductible Options: \$500, \$1,000, \$2,500 or \$5,000.

Coverage includes:

- Replacement cost without deduction for depreciation, subject to the applicable limit of insurance.
- All risk coverage subject to the exclusions specified in the tack equipment coverage form.
- Worldwide coverage including while in transit.

The following additional coverages are included when scheduled tack equipment coverage applies:

- **Replacement items:** tack bought during the policy period to replace an item scheduled on your policy are covered up to 30 days, subject to the limit specified in the tack equipment coverage form.
- **Newly acquired:** tack you purchase during the policy period is covered up to 30 days, subject to a \$2,500 limit.
